Rotary International's Legislative Body (Parliament since 1974 -Advisory body from 1934)

What happens at Council on Legislation?

Meets every 3 years in Chicago

- Able to amend RI Constitution
- Every Club and District may propose legislation
- Council has authority to adopt its own rules of procedure

What happens before the Council Meets

- Proposed legislation had to be properly submitted by 31 December 2017
- RI Staff check
- Constitution and Bylaws Committee review
- Purpose and Effect Statements and Financial Impact Statements
- Any further redrafting is undertaken
- Final determinations are done


Enactments seek to change RI's Constitutional documents:

Who are the Council members? Voting members: One elected Rotarian from each Rotary District

- Must have served a full term as an RI Officer (Past District Governor)
- Must be a member of a Rotary Club in that District

- The Chairman, Vice-Chairman and a Parliamentarian (appointed by the RI President)
- RI Constitution and Bylaws Committee
- As many as 3 Members-at-large (appointed by the RI President)
- RI General Secretary
- RI Board

There were a number of matters that may impact Rotary in the years to come

Admission to Rotaract to RI

Establishment of RI as a charity for tax purposes





What will it mean for clubs?

- 19-22 Prohibits club President from serving more than 2 terms consecutively
- **19-24** Requirement to clarify club reporting at club
- annual meetings
- **19-29** Aligns financial reporting requirements for satellite clubs with those of clubs
- **19-28** Clarifies that new clubs may be started in localities with other clubs
- **19-30** Improves the language of the standard club constitution to clarify flexibility options
- 19-35 Removes the restriction of being credited for an attendance make-up with 14 days either side of the regular meeting date. Credits are available now for any make up within the Rotary year



19-37 Removes language about holders of public office being unable to have membership under the classification of said office, as they can already hold membership under their existing classification

19-39 Removes numerical restrictions on classifications, requiring clubs to have a well-balanced membership in which no one business, profession, occupation, type of community service, or other classification predominates. This recognises the current reality

19-52 Extends the challenge period for Governor Nominee Elect from 15 to 30 days

19-57 Extends the period for providing an independently reviewed annual statement of district finances from 3 months to one year. This would probably not be consistent with our requirements as an incorporated entity



19-58 Provides a mechanism to call for a district legislation meeting if a majority of club Presidents request it

19-70 Permits the RI Board to terminate a club on request of the DG if its membership falls below 6 member

- **19-100** To clarify district endorsement of club resolutions through a ballot-by-mail process
- **19-82** Approves dues increases by US \$1 per year for 3 years commencing from 2020 2021

19-115 To modernise and streamline RI Bylaws without making substantive changes

19-116 Modernises and streamlines standard club constitution without making substantive changes



What now?

- Discuss with your club
- Decide if you want to oppose legislation
- You will need to have your club incorporation documents updated to incorporate changes
- District will advise on options for doing this
 - Do your own
 - Use a lawyer such as McKeanPark
 - Consider other options that District is evaluating



VOTING DEVICE

When the vote is open, the device will display the 2 options, 1 for "Yes" and 2 for "No." You can simply press the number that corresponds with your choice.
